5. In the event that MYTV-26 receives a complaint indicating that the Program Agreement has been violated, producer agrees to postpone playback until MYTV-26 can verify Program Agreement compliance.

WARRANTY AGREEMENT: I understand, warrant, and represent to MYTV-26 that the above program submitted by me contains none of the following:

1. Any material that is slanderous, in defamation of character, or an unlawful invasion of privacy.
2. Any material contrary to local, state, or federal laws.
3. Any advertising or material that promotes any commercial product or service.
4. Any solicitation or appeal for funds.
5. Any unlawful use of copyrighted material.
6. Any material which has a reasonable probability of creating an immediate danger or damage to property, creating an injury to person(s), or creating public nuisance.
